

State Legislative Report — May 2014

- We now have one new sponsor for both the Senate and Assembly versions of the NJ Motorcycle-Only Checkpoint Bill. Senator Mike Doherty (R-23) signed on as a Prime Sponsor of Senator Jeff Van Drew's (D1) S1614 bill and Assemblyman Ralph Caputo (0-28) has signed on as a Co-Sponsor for Assemblyman Bob Andrzejczak's A2316. These new Sponsors now bring the totals to two sponsors on the Senate Version and six sponsors on the Assembly version. I am hopeful that the recent AMA Action Alert for NJ will prompt many riders in our state to contact their legislators and this will produce even more sponsors for the MOC bill. According to the NJ Legislative Calendar there are no committee meetings or votes scheduled for S1614 or A2316 through June 30, 2014. (5/28/14 through 6/30/14)

- On May 15, 2014 five New Jersey ABATE riders attended the sixth annual "Biker's Inside the Beltway" Congressional lobby day in Washington DC. We joined bikers from 16 other states who converged on the Capitol to participate in this event hosted by the MRF (Motorcycle Riders Foundation). Even though riding in DC traffic is no fun at all, going to Washington to participate in this event is an inspiring thing to do. To be able to walk the halls of our government and meet with the people who make and changes to our federal laws is something that only we as Americans have the Constitutional right to do. The First Amendment of the U.S. Constitution guarantees us the right to "To petition the government for a redress of grievances" (redress = remedy). This means that as citizens we can ask for changes in the government. We can do this by collecting signatures and sending them to our elected representatives; we can also write, call, e-mail or visit them in person. Or we can support groups that lobby the government on our behalf. Our group from NJ visited the offices of all eleven of our Congressmen; there is currently one vacant office. While in Washington, we got to meet with the Transportation Staffers for Congressmen Leonard Lance, Jon Runyan, and Rodney Frelinghuysen. After visiting our Congressional offices, we got to meet and hear Senator Jeanne Shaheen (I-WI) who introduced the federal MOC bill (S-2078) which will stop federal funding from going to states and municipalities for the purpose of conducting motorcycle-only checkpoints. We also heard Senator Ron Johnson (R-WI) who is a co-sponsor on the federal MOC bill. It was great hearing what these two Senators believe regarding this subject. Two other Senators, Kelly Ayott (R-NH) and Joe Manchin (0-WV) are also co-sponsors of that bill. The bill has bi-partisan support.

Except for a very brief sprinkle as we were leaving DC, the rain held off for the sixth year in a row for BITB. We had a nice ride and a nice visit to the Capitol and we are looking forward to BITS 2015. I hope you will join us. The experience of participating is well worth the trip.

- Laws & regulations relating to insurance discrimination for activities deemed "risky or 'dangerous' by insurance companies. George has further information to report about this.

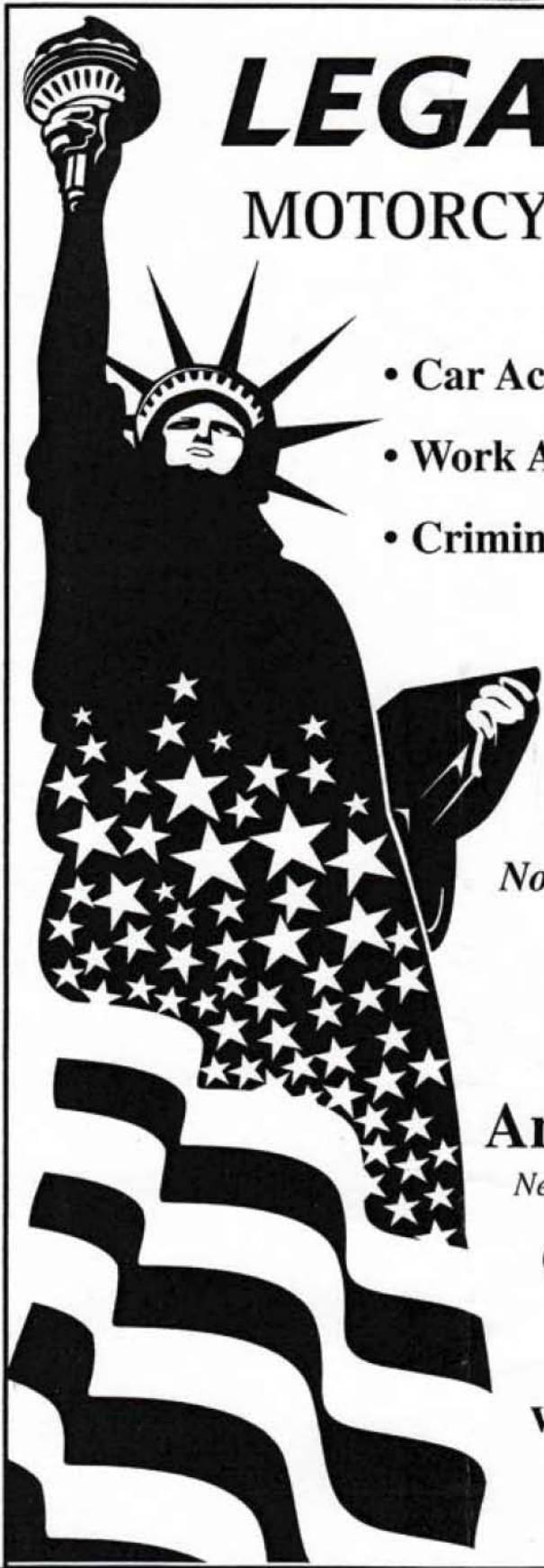
