LEGISLATIVE;

Maryann and Frank meet with Senator Nilsa Cruz Perez. We discussed the distracted driving law, and she knows someone who was ticketed for her rosary hanging from the rear view mirror. We gave her the Ethanol 15 explanation. She wasn't sure what she can do at the state level but she is going to have Chris check it out for us to see what we can do. We asked about the right of way bill, and I brought up veterans plates knowing that she was veteran she jumped right on it. Spoke to her briefly at the end about the problem with colors and being a minority she understood that.

They also voted on veterans plates for motorcycles. It also passed unanimously, and now awaits action by the Assembly.

The MRF is not supporting the new Bill HR 2414 (Black Box), this bill endorses "black boxes" in all vehicles, including motorcycles.




